- Watering between 9a.m. - 4p.m. (L.A.M.C. Sec. 121.08 A.7.)
- Allowing excess water from sprinklers to flood gutters. (L.A.M.C. Sec. 121.08 A.9.)

Penalties for failure to comply with Section 121.09 are set by Los Angeles Municipal Code as follows:

1 ST VIOLATION	WARNING	WARNING
2 ND VIOLATION	\$100.00	\$200.00
3 RD VIOLATION	\$200.00	\$400.00
4 TH VIOLATION	\$300.00	\$600.00

Penalties assessed will appear as a charge on the customer's LADWP water bill.

You May Request A Hearing. Any customer against whom a penalty is levied pursuant to this section shall have a right to a dispute determination, in the first instance by the Department, with the right of appeal to the Board of Water and Power Commissioners, on the merits of the alleged violation, upon written request of that customer to the Department within fifteen days of the date of notification of the violation.

Reservation of Rights. The rights of the Department hereunder shall be cumulative to any other right of the Department to discontinue service. All monies collected by the Department pursuant to any of the surcharge provisions of this article shall be deposited in the Water Revenue Fund as reimbursement for the Department's costs and expenses of administering and enforcing this article.
